In the event of death, this advance payment shall not be less than 16 000 SDRs. In respect of destruction, loss of, or damage or delay to baggage: In case of checked baggage, liability is limited to 1 519 Special Drawing Rights. If the value of your baggage exceeds the applicable limit of liability, you should fully insure it before you travel.
